

## Mount Olive's Journey Toward Climate Justice

- June 2015. Mount Olive Missions Committee explores what Pope Francis's environmental encyclical (<u>http://www.catholicclimatecovenant.org/encyclical</u>), issued a month earlier, means for people of faith – and what it could mean for Mount Olive.
- **December 2015.** Under Missions Committee leadership, Mount Olive becomes a partner congregation of Minnesota Interfaith Power & Light (MNIPL), a non-profit organization dedicated to bringing together faith communities to advance climate justice as an integral part of spiritual life and social justice.
- December 2015. Language of the Paris Agreement

   (http://parispledgeforaction.org/read/) is adopted by consensus by 195 nations.
   The agreement within the U.N.'s Framework Convention on Climate Change
   deals with greenhouse gases emissions mitigation, adaptation and finance,
   starting in the year 2020.
- **Early 2016.** The Mount Olive Property Committee establishes a task force to research a heating/cooling/ventilation system and recommend energy updates for the building, keeping in mind a growing call for air conditioning in the sanctuary and undercroft. The committee enlists a solar energy vendor and an architecture firm to develop recommendations and estimates.
- **February 2016.** Minnesota Interfaith Power & Light encourages Mount Olive to apply for a state-funded grant to support the purchase and installation of solar panels on the Parish House roof. MNIPL assists Mount Olive in applying.
- **April 2016.** Mount Olive wins the state solar funding grant. The congregation votes unanimously to move forward with solar panel installation.
- April 2016. The Mount Olive Missions Committee submits a recommendation to the Vestry that calls for the church to follow the nation and the world in adopting the Paris Agreement.
- **May 2016.** The Vestry requests that the Missions Committee establish a task force to determine how the church might "live into" the environmental goals of the Paris Agreement.
- **Summer 2016.** The Missions Committee establishes a Climate Justice Task Force to examine how Mount Olive might adopt and achieve the principles and goals of the Paris Agreement. The Task Force is to deliver a proposal for how the congregation might move forward. The Task Force:
  - Produces "Gentle with the Earth," a theologically based rationale for committing, as a congregation, to the Paris Agreement.



- Provides a list of resources that the congregation and its members might use to guide more environmentally friendly decisions and actions.
- Recommends that the Vestry establish a committee or task force to guide and support the congregation in adopting climate justice attitudes and behaviors.
- September 2016. President Barack Obama joins the U.S. with 190 other nations in signing the Paris Agreement. His remarks are here: <u>https://obamawhitehouse.archives.gov/the-press-office/2016/10/05/remarks-</u> president-paris-agreement
- Fall 2016. The Vestry votes to approve "Gentle with the Earth" and present it to the congregation for a vote.
- **November 2016.** The Paris Agreement goes into effect, having been signed by enough countries that produce enough of the world's greenhouse gases for the agreement to enter into force.
- **December 2016.** The Vestry establishes a Climate Justice/Gentle with the Earth Advisory Committee, to serve as a "think tank" and resource for ideas for the Vestry and the church's committees and members.
- **February 2017.** The Missions Committee highlights climate justice at its annual "Taste of....." event, which features sustainable recipes. An Adult Forum features the MNIPL staff leading a climate conversation. (Several other Climate Justice speakers conduct Adult Forums in 2016-2017.) The Passport for Climate Justice Journey kicks off. The initiative invites members to go on a seven-week journey to change patterns, grow in understanding, lend support to each other and have fun exploring ways to lower environmental impact.
- **Spring 2017.** Members of the Climate Justice Advisory Committee meet with committees of the congregation to encourage climate justice and environmental stewardship in future decisions and actions and to urge them to look to the Advisory Committee for ideas, resources and support.
- March 2017. Mount Olive members approve a capital campaign to assess the ability and willingness of the congregation to fund building improvements, including a geothermal heating, air conditioning and ventilation system for the church and undercroft, among other projects.
- April 2017. The Congregation votes to adopt the Paris Pledge.
- June 2017. President Donald Trump cancels U.S. involvement in the Paris agreement.
- June 2017. The Congregation approves the geothermal project.
